<u>AUTHORIZATION TO PURCHASE - SKID STEER WITH TRAILER &</u> ATTACHEMENTS

Lewis that upon the recommendation of the Road Supervisor, to authorize the purchase of a Caterpillar 262D Skid Steer with Street Broom at a cost of \$51,601.00 and a Towmaster Trailer in the amount of \$5,562.00 plus the following attachments: Brushcutter \$5,700.00, Snow Blower \$7,677.00 and Bucket \$4,585.00 for a total cost of \$75,125.00. This purchase is from Cleveland Brothers Equipment Co. Inc. under State Contract #440001141 and is financed with an LSA Grant of \$75,000.00.
